Nita Farahany

*Legal Scholar and Ethicist,
Director of the Duke Initiative
for Science and Society*

Nita Farahany is a leading scholar on the ethical, legal, and social implications of emerging technologies. She is the Robinson O. Everett Distinguished Professor of Law and Philosophy at Duke Law School and the Founding Director of Duke Science & Society. She focuses on the implications of emerging neuroscience, genomics, and artificial intelligence for law and society; legal and bioethical issues arising from the COVID-19 pandemic; FDA law and policy; and the use of science and technology in criminal law. Farahany is the author of *The Battle for Your Brain: Defending Your Right to Think Freely in the Age of Neurotechnology*. Farahany earned an undergraduate degree in Genetics, Cell, and Developmental Biology from Dartmouth College, an MA in biology from Harvard University, and a JD and MA from Duke University, as well as a Ph.D. in philosophy.



Alli Daley

*Policy Director, Partners
for Children's Mental Health*

Alli Daley serves as the Policy Director at Partners for Children's Mental Health and the Senior Behavioral Health Policy Coordinator on the Government Affairs team at Children's Hospital Colorado. Prior to her time at Children's Colorado, Daley litigated mental health and substance use disorder commitments as an Assistant City Attorney with the City and County of Denver. Before that, she lobbied on behalf of Colorado counties at the state legislature. Daley has a BA from Boston University and a JD from the University of Colorado Boulder.

He also founded access.mobile International, a global digital health company that developed solutions to improve access to health information and services in African countries. Yelapaala received a BA from Brown University and an MPH from the Yale School of Public Health.



Guadalupe Solís

Director of Environmental Justice, Cultivando

Guadalupe Solís joined Cultivando in April 2023. She brings relevant experience in community health needs assessment planning, public health surveillance, and health policy interpretation and analysis. Solís has guided herself through her strong passion for increasing access to health care, advancing health outcomes, and addressing barriers in the way of the health and well-being of her community. She earned her bachelor's degree in biomedical sciences from the University of Northern Colorado and a master's degree with a dual emphasis in epidemiology and health systems management and policy from the Colorado School of Public Health at the Anschutz Medical Campus.



Judy Amabile

Colorado State Representative, District 49

Rep. Judy Amabile was elected to the state House in 2020. She has sponsored measures to increase mental health resources, improve the criminal justice system, increase gun safety, and make communities more resilient in the face of wildfires fueled by the climate crisis. Her son developed a serious mental illness at age 18. She was inspired to seek public office after experiencing our broken mental health care system firsthand. She serves on the House Public & Behavioral Health & Human Services Committee and is chair of the House Business Affairs & Labor Committee. Her district includes mountain communities from Clear Creek to Larimer counties.



Rhonda Fields

Colorado State Senator, District 28

Sen. Rhonda Fields is chair of the Senate Health and Human Services Committee. She has passed over 30 bills in the Senate on community safety, social equity, access to health care, and defending Colorado's middle-class families in meaningful ways. Most recently, she sponsored legislation on cultural training for mental health providers and behavioral health care for people working in the criminal justice system. Fields was elected to the House in 2010 and to the Senate in 2016. She lives in Aurora.



Chris deGruy Kennedy

Colorado State Representative, District 30

Rep. Chris deGruy Kennedy focuses on health care reform, fiscal reform, climate change, and election systems. He has been a leading voice for some of the most important health reforms of recent years, including hospital transparency, the state reinsurance program, the prescription drug affordability board, and value-based payments in primary care. He was elected to the state House in 2016 and is Speaker Pro Tempore of the House. He lives in Lakewood.



Jim Smallwood

Colorado State Senator, District 2

Sen. Jim Smallwood champions affordable and accessible health care for Coloradans and has fought to reduce insurance premiums while working to ensure that all Coloradans have access to quality health care. He also advocates for transparency and fiscal responsibility in government spending. Smallwood was elected to the Senate in 2016 and is the Senate Minority Caucus Chair. He is an insurance broker and lives in Parker.



Youth Leaders

Colorado Youth Congress (CYC), Young Aspiring Americans for Social and Political Activism (YAASPA), and Youth Council on Mental Health (YCMH)

The YCMH is convened by Partners for Children's Mental Health and is a youth-led, adult-supported effort to positively shape the future of youth mental health in Colorado. This year, YCMH has identified social media use as a priority and focus area. The CYC is a youth-led initiative committed to elevating the voices of Colorado youth through empowerment and civic engagement. YAASPA aims to build the self-efficacy of youth who desire to make change in their communities, pursue social science degrees, and social justice careers.



Karam Ahmad

Director

Karam Ahmad leads CHI's Acclimate Colorado health and climate work and oversees evaluation for multiple client projects. His CHI portfolio covers a variety of health policy issues ranging from integrating systems of care, health policy leadership, oral health, healthy equity, behavioral health, and more. Before joining CHI, he worked as a technical writer for Otter Products, LLC (more commonly known as OtterBox). He also was an analyst for the National Park Service and USDA Center for Epidemiological Animal Health. Ahmad earned an MPH from the Colorado School of Public Health at Colorado State University and a certificate in Climate Change and Health from Yale University.



Nina Bianchi

Director

Nina Bianchi has 20 years of experience leading public-private health partnership growth through community innovation, collaboration, and communication. Prior to joining CHI, Bianchi was a Principal for Medallia, where she helped clients accelerate equitable health systems transformation, and was Chief of People and Culture for the U.S. Food and Drug Administration, a special COVID-19 leadership appointment to support human-centered modernization efforts with the Office of Digital Transformation. Bianchi was a White House Presidential Innovation Fellow with the National Cancer Institute and the IT Modernization Centers of Excellence. She designed and managed public-private consulting projects for equitable artificial intelligence at the intersection of patient experience, employee experience, and digital health service delivery. She earned a BFA in communication design from the College for Creative Studies in Detroit.



Jeff Bontrager

Director of Research & Evaluation

Jeff Bontrager oversees CHI's evaluation portfolio and coordinates research efforts related to health insurance, Coloradans who lack insurance, the health care safety net, and health equity. He also supports CHI's Acclimate Colorado team. He serves as principal investigator on the biennial Colorado Health Access Survey and the annual evaluation of The Denver Foundation's Colorado Health Access Fund. Bontrager was a founding member of CHI's Inclusivity, Diversity, and Equity Alliance, and provides facilitation, leadership, and technical expertise for a variety of advisory groups. He earned an MPH from the University of Colorado.



Ashlie Brown

Director

Ashlie Brown focuses on complex systems change — including health information technology, health care delivery systems, and payment reform — and leads CHI's Integrating Systems of Care initiative. She oversaw the development of Colorado's Regional Health Connector Program within a multi-organizational collaboration. Before moving to Colorado, Brown managed the implementation of the Massachusetts State Innovation Model at the Massachusetts Executive Office of Health and Human Services, an effort that included Medicaid payment reform, behavioral health integration in primary care practices, and electronic clinical-community linkages to support population health. She previously worked in the medical device industry and holds two degrees in mechanical engineering.



Joe Hanel

Director of Communications

With nearly 20 years of experience at Colorado newspapers, Joe Hanel communicates CHI's work to a broad audience, including news reporters, legislators, health advocates, and voters. A member of CHI's legislative team, Hanel performs research and analysis on the intersection of politics and policy and the interaction of federal and state health policy. He developed a financial map that tracks federal funds for Colorado governments and agencies through the American Rescue Plan Act. Director of Policy Analysis

Emily Johnson uses financial modeling and other forms of quantitative analysis to study how both local and federal health policy proposals could affect Colorado, its budgets, and its residents. She oversees CHI's behavioral health portfolio and leads data analysis for the Colorado Health Access Survey. During the pandemic, Johnson supported the governor's Innovation Response Team and served as a member of CHI's elite Strike Team, formed to quickly respond to the public health crisis. She holds a master's degree in health services research from the University of Colorado. Her academic work focused on the associations between state regulations and nonprofit hospital community benefit spending and behavior.



Kirsti Klaverkamp

Senior Program Manager

Kirsti Klaverkamp oversees development and execution of programs and projects across multisector stakeholder groups, including public health, human services, and community-based, clinical, government, and business organizations at CHI. Prior to joining CHI, she managed operations, quality improvement activities, and regional work groups for the Accountable Health Communities Model, a demonstration project under the U.S. Center for Medicare & Medicaid Innovation. Research Analyst

Kendra Neumann convenes and engages stakeholders, conducts community health needs assessments, and provides qualitative and quantitative analysis and support on various CHI projects. She serves on CHI's legislative team and created and updates The Colorado Health Foundation's Local Ballot Measure Tracker. As a research assistant at Denver Health, Neumann recruited participants for an opioid use disorder treatment study and administered surveys to study participants. Sara Schmitt

President and CEO


Sara Schmitt assumed the role of President and CEO of CHI in June 2023, after more than a decade in progressive leadership roles with the organization, including Managing Director of Research, Evaluation, and Consulting and interim President and CEO. Before joining CHI, Schmitt was a policy analyst at the Colorado Rural Health Center, the state office of rural health, and recruited physicians and other medical professionals for clinics and hospitals in Colorado's rural and underserved regions. She spent several years in managed care and program development at the University of Chicago Medical Center. She earned a master's degree in health administration and policy from the University of Chicago.
