## **Elements of a Healthy Democracy**

- Trust In government
- Confidence in our institutions
- Inclusive of all citizens
- Equal opportunity to vote and be heard
- Civic participation voting, staying informed, advocating for needs and priorities



## **Public Institutions**

- Efficient and accessible
- Ability to meet the basic needs of the population (health, safety, education)
- Voting as a public health issue
- Speaking up for those who cannot speak for themselves



Voting Access & Barriers

Communities with more inclusive voting policies have more social cohesion, stronger community conditions, and better health.

## Voting in Colorado

- All mail voting
- Extensive network of VSPC and ballot drop boxes
- Automatic Voter Registration
- Online voter registration & updates
- Voter registration permitted through election day



## What barriers remain?

- Population specific some groups more likely to experience difficulty voting
  - First-time & young voters
  - Low-income & historically marginalized populations
  - Elderly voters & voters with disabilities or mobility issues



### Voting in Colorado – 2020 General Election

Colorado had one of the highest voting participation rates in the U.S. (76%) Youth turnout in Colorado was also among the best in the nation (64% among 18-29 year olds) But....nearly a quarter of eligible voters didn't participate. How do we change this?

## Voter Education & Mobilization are Key

Increasing voter participation rates among young people

- Online voter registration, pre-registration (16 yrs), and updates
- Public high schools must designate staff member to be trained in voter registration to assist students
- CO colleges & universities are treated as a national voter registration agency
- Voter outreach; commit to vote postcards/text messages
- Text2Cure



## Voter Education & Mobilization are Key

- Increasing voter participation rates among marginalized or low-income voters
  - Online voter registration and updates
  - Voter registration through TANF or food stamps application
  - Onsite voting in jails
  - Vote Center Siting Tool



## Voter Education & Mobilization are Key

- Increasing voter participation rates among elderly or disabled voters
  - Online voter registration and updates
  - Onsite voter registration at assisted living facilities; mobile VSPCs

#### 2024 General Election Deadlines

Ballots mailed beginning Oct. 11; must be received by 7:00 pm on Nov 5 Oct 21 – Nov 5 – VSPCs and drop boxes open to voters Nov 7 – County Clerks to notify voters of need to cure Nov 13 – Deadline for voters to cure any ballot issues

## **Ballot Initiatives**

• Ballot initiatives ask voters to decide important issues that impact our health & wellbeing. Examples include:

- Amendment 79 (2024) Constitutional Right to Abortion
- Proposition EE (2020) Nicotine Tax to Fund UPK
- Proposition 118 (2020) Paid Family & Medical Leave Program
